 7. In giving permission to publish a manuscript, photograph, or other item from OSA collections, the OSA does not surrender its own right thereafter to publish the manuscript, photograph, or item, or to grant permission to others to publish it.
 8. If published online, the URL of the website should be provided to OSA. For hard copy or digital publications containing the materials listed on this permission form, it is courtesy (not required) to provide OSA with a complimentary copy, preferably digital (but not required).
